Notes

Overall, income has exceeded expenses so far this year, which is better than expected. This is in large part due to the highly succesful ANR Week Seminar. The \$200 September expense under line 8 is to reserve the space for the 2020 program. One other expense item of note that exceeded the budgeted amount was line 11. This exceedance was approved by a vote of the Executive Council to cover expenses for Chapter Secretary, Daniel Kesselring, to the International Conference to accept an award. Several expenses will still be incurred this year, including expenses related to the annual meeting, the MACD Fall Convention and final payment to the Communication Intern. Even with these final expenses, the budget will end the year with an anticipated net revenue of \$800+/-.
