#### **New Business:**

Grand Valley State University SWCS Student Chapter Funding Question: Dan K. explained that the GVSU Student Chapter does not have any actual SWCS Student Members in it. It only has members of the Student Chapter, with fees paid to the Chapter, not to SWCS. This has been an issue for several years and, as a result, the Michigan Chapter had authorized sending \$100 to the Student Chapter each year to be used to "cost-share" with a few GVSU Student Chapter members the cost of student membership in the parent society. We're not sure if that has ever been accomplished. The donation check has been cashed, but sometimes there's a long delay before it's cashed. So, Dan is suggesting that maybe we should provide

2 or 3 student memberships to officers of the GVSU Student Chapter instead of donating cash to the student chapter.

After some discussion, Tess Van Gorder moved, due to time limits, to table this discussion for now. Supported by Gerald Miller. No vote was taken, but motion assumed passed by lack of descent.

**Strategic Plan Draft Review:** Katie explained that the draft plan has been shared with all officers, and that she had asked officers to send comments to Glenn O'Neil. After some discussion about lingering concerns, *Katie then again requested each officer to review the Strategic Plan and send their comments to Glenn.
