

Natural Resources Conservation Service Report Michigan Agroforestry Working Group January 28, 2025

Silvopasture (Code 381):

- Conservation Practice Standard (CPS), Guidance Document (GD) and Implementation Requirements (IR) published February 2024.
- Available for funding in EQIP for FY 2025:
 - 7 "tree establishment scenarios, \$2.57 \$38.22 per tree (payment based on plant size, and supplemental measures, e.g., cages, shelters).
 - 2 "non-commercial forest thinning + establish forage" scenarios, \$899 (introduced grasses) and \$982 (native grasses).
 - o 1 "establish forage/no thinning needed" scenario, \$251
 - o Payments increase for Historically Underserved clients, and in certain counties.
- Early adopters NRCS participants with plans under development:
 - Osceola Co.; acres TBD; pigs; existing woods.
 - Lapeer Co.; 2.3 ac.; sheep; existing forest.
 - Osceola Co.; 9.3 ac.; sheep; scotch pine plantation to be cleared and replanted.
 - o Barry Co.; 11.5 ac.; cattle; existing forest.
 - Kalamazoo Co.; goats; approx. 6 ac. existing forest, 6 ac. existing WSG, 3 ac. old field.
- Early adopters NRCS employees with Job Approval Authority:
 - Greg White, District Conservationist, Reed City
 - o Zach Whitacre, Soil Conservationist, Hastings

Forest Farming (Code 379):

- New to Michigan! CPS and IR published January 2025.
- Likely available for funding in FY26.

Alley Cropping (Code 311): No Updates.

Riparian Forest Buffer (Code 391): No Updates.

Windbreak/Shelterbelt Establishment and Renovation (Code 381): No Updates.
